We may revoke this contract at any time by giving a refund and may make changes to scheduling as they see fit. If party receiving the camp program wishes to cancel or discontinue, any & all pre-paid money will be forfeited. **No refund for early withdrawal. No exceptions!** We prepay all activities.

Cost of camp is \$235/week/child (\$220 if enrolled in 4 or more weeks) for camp hours of 9:00-3:00 (Child must be present by 9am to participate in all activities as many start early and kids have to be on their way by the drop off time). Please make checks payable to MSMA or fill in the credit card authorization section below. Payment is due upon enrollment to guarantee their space in the camp. Credit/debit card will be kept on file and be used to pay for weeks in advance as they come up. Daily rate is \$60/day (add \$10 for extended day) Must purchase uniform with extended afternoon for karate classes (\$30).
